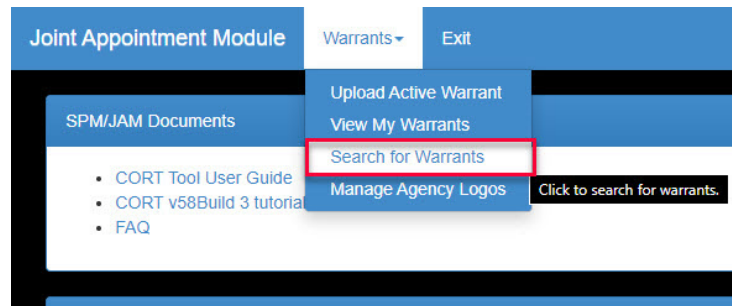
Roles

Search for Warrants

Log into PIEE and access JAM. In JAM go to **Warrants > Search for Warrants**

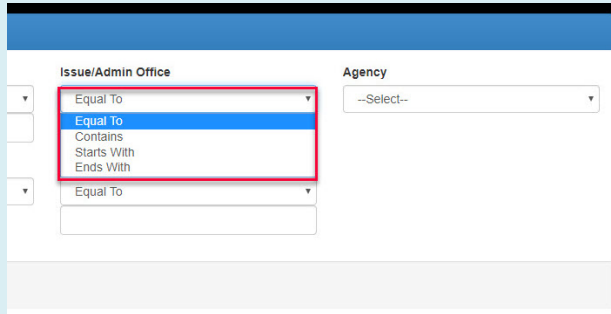


Search for Warrants – Search Criteria

Enter any criterion to search for warrants in JAM

Search Criteria:

- First Name
- Last Name
- Issue/Admin Office
- Agency
- Warrant Number (System Generated)
- Status
- Status Date



Search Modifiers:

- Equal To – Searches field for values that match.
- Contains – Searches fields that contain the entered value.
- Starts With – Searches fields where the field starts with the entered value.
- Ends With – Searches fields where the field ends with the entered value.
